I must apologize for the fact that the 2019 annual report is inordinately delayed. This is only due to the process of elaborate analysis of our quality of service, road mapping and scrutinizing the financial-activities of Compassionate Crusaders Trust (CCT') during the last 25 years. But to compensate for the laps we have decided to include account and audit reports of two consecutive years including our latest audit report 2019-20. I must also admit here that some of our activity report are not documented fully for truncated input due to lock down situation; The lessons that we have learnt due to double pronged attack of economic uncertainty in the country, post covid- 19; and also the destructive high intensity storm amphan. Demise of Mr. K.P.S Memon - 28th September, 2019. The commemoration of Compassionate Crusaders' silver jubilee has been a mixed bag. We were struck by the sudden demise of our most beloved past Patron Mr.K.P.S. Menon (Junior), who left us last year with the setting sun of the 28th September. His presence as the patron of Compassionate Crusaders Trust was like solar energy not visible but ever invigorating. With

his death we realized, like never before/ that death ends a life but not a relationship.

For the first twenty five years of our existence, Starting or our journey on November, 1993 with a tiny sum of rupee one thousand as our total asset. Compassionate Crusaders Trust has completed 25 (Twenty five) years of service for the mutes. Our motto has been *no dream too foolish, no goal too high*.

Now, as I go on to narrate our activity profile, we have tinge of satisfaction that all through the tedious and difficult period our mutes in our care have not suffered single scratch or have not missed a single meal.

We humans need to care and make even the tiniest creature on this earth not only survive but thrive too, for our own survival.

Metaphysically speaking, evil is the permanent law, and what is good is an effort. Due to our unrelenting effort, spread over a quarter of a century, many of CCT's ideas have been accepted through legislation by our own country and even other civilized nations. Some more have reached the highest level of judiciary and the religious & community leaders.

Now global society accepts Compassionate Crusaders' contention that, atrocities on human is tried under the law as "crime on human society" whereas atrocities on 'mutes' is considered as breach of humanity.

There are two days in the year that we cannot do anything, yesterday and tomorrow. This has been the driving force with Compassionate Crusaders Trust's existence of a quarter of a century. The year Twenty eighteen is our landmark silver jubilee year.

Before Compassionate Crusaders Trust came into being, awareness about environment, animal rights, related human health issues were all quite vague and sporadic in our country. Non-human liberation movement has always been dominated by 99% heart, 01% brain. Thus allowing the "brainy" exploiters easy option of a 'pass by' and continue their vile act, more often to their own peril and to that of the generations to come.

The words of Martin Luther King Jr., There comes a time when one must take a position that is neither safe, nor politic, nor popular, but he must take it because conscience tells him it is right. A small step forward last year was CCT's initiation of military animals' retirement. This year it is followed by the Government's initiative of a pension and lifelong shelter/ rehoming of retired military animals We recall with all humility how WB Police Horses' retirement was also initiated by CCT, providing peaceful retirement home to start with. Now police authorities In both Kolkata & State provide for post retirement rehabilitation of their Dogs & Horses.

At Compassionate Crusaders our actions & activities are constantly filtered through the revered monk of Ramakrishna Mission, Swami Ranganathanandaji's saying "Are you growing spiritually? Can you love others? Do you feel oneness with others? Have you peace within yourself and do you radiate it around you? That is called spiritual growth, which is stimulated by meditation, inwardly, and by work done in a spirit of service outwardly." All our workers and volunteers serve the 'mutes' in a meditative spirit. The two issues, a positive and a negative mentioned below make it emphatic.

Chhoti, a sheltered dog is a living statement of the unrelenting dedication of our workers towards our stand on complete unacceptability of subjugation of animals under any pretext. Chhoti, a three month old puppy, had her hind legs crushed under a car and was rescued from the road. Since 2015 (TILL2019), Chhoti was living a life of freedom in spite of non functioning hind legs. A 'custom-made' doggy cycle for Chhoti, organized by our workers at Karuna Kunj, is made it possible. "If trees were included in electoral roll as voters, then they would remain," a Delhi High Court bench of justices Badar Durrez Ahmed and Ashutosh Kumar said.

The judges made the observation last year after being told that a huge number of trees have been felled by authorities like Delhi Metro for projects and by encroachers in places like the Asola-Bhatti wildlife sanctuary on the southern fringe of the city.Quite a few of CCT's humane ideas have spread evenly all across the country, some even globally. Rampant destruction & degradation of wetlands all over the country sounds as alarming. Closer home, one of CCT's distinguished Life Members, Late Dr. Dhrubajvoti Ghosh, a UN Global 500 laureate and crusader for the East Calcutta Wetlands, has been making an impassioned plea for the protection of the water bodies and farmland covering 12,500 hectares and the people who eke out a living there from land sharks. We are hopeful of a positive initiative by the authorities for a sustainable urban development to keep Kolkata habitable in the long run. You need regular sign-posts if you're to find your way along

You need regular sign-posts if you're to find your way along life's journey. Along with common Calcuttans who are by and large kind, one major achievement of Compassionate Crusaders have been in changing the attitude of the 'authorities'! Kolkata is unique in one humane aspect, here Army, Airport & Police have been taking our help & guidance in 'humanely' solving all animal related issues & problems.

CCT has been one of the first, in mid 1990s, to raise the issue of exploitation of human 'performers' in circuses. Most of the children (even a majority of the adults) are virtual bonded workers; devoid of basic insurance, post retirement benefits, even 'protection' in case of permanent disability due to injury during a performance. Now it is a part of our national agenda.

CCT's idea of active compassion to curb animal sacrifice and suggestions on 'blood donation camps' to replace 'ritual of dripping blood' is catching up, even in remote villages.

CCT's vigilance against wildlife trade continues. Our antipoaching drive and goading the appropriate authorities to regularly 'haul up' wild birds and turtles from the grey markets has become a 'routine', making a significant dent. Our volunteers from all walks of life have been ever vigilant.

Campaign against "cattle smuggling" is gaining momentum by the day. Our 10 year long interaction, person to person, from the highest officer to the rank & file of the Border Security Force (BSF), the valiant protectors of our nation's boundary, has been the key.

CCT's stand on 'caged zoo' is very emphatic, as our campaign "Life imprisonment without a court of appeal" tells. Cages are meant for stopping animals from coming out but not for stopping visitors from entering them. There is a serious need for considering CCT's idea of reverse zoos where visitors are guided through secured tunnels with animals and birds roaming free all around. There is a small spot of 'reverse zoo' inside Sunderbans Tiger Reserve. We need to have such facilities in the urban zoos too.

CCT have been unrelenting in the campaign against human encroachment of tiger habitat in Sunderbans. Our view is very clear, if mangrove cover disappears, tigers will follow and even human habitation will not be sustainable anymore. A Frenchfunded project with 18,000 women playing a critical role in countering climate change by creating and regenerating mangrove forests across nearly 4,500 hectares in the Sunderbans. This effort is duly acknowledged on the website of the United Nations Framework Convention on Climate Change.

CCT campaign to check Elephant depredation is yielding result. From unique awareness campaigns and SMS service to elephant dossiers and state-of-the-art vehicles to tackle conflict situation, the forest department's bid to check mananimal conflict in south Bengal seems to have yielded a positive result. Human casualty figure has been substantially reduced, from 71 year before last to 32 last year, as reported.

Unlike the East Kolkata Wetlands, Eco Park, in New Town, (near Kolkata) has been groomed carefully to preserve it's natural surroundings over the last five years and now being acclaimed amongst global urban parks.

On the flip side, amongst all the 'positive' effects of our campaign, we can not relent. "Every morning we are born again. What we do today is what matters most.", the words of Gautama Buddha, the ultimate compassionate crusader, can not be over emphasized as the incidents covered by the media exemplified a ripple of compassion individually or institutionally among the general public as a result of our activity.

Numerous incidents of wild animals like Tigers, Leopards, Elephants, Bisons being trapped or killed all over the country is deplorable.

Last year Veterinarians at an institute in Tamil Nadu's Thanjavur have removed 38.4 kg of plastic bags and a LED bulb from the stomach of a bull. The bull was brought by its owner following anorexia and debility. "Plastic waste equivalent to the weight of roughly a billion elephants is poisoning our planet! It includes every plastic spoon, straw, packet of chips, and PET bottle you and I have used and thrown away." is a statement of fact which can not be more emphatic.

A faux pas in 2008 on the part of the Animal Welfare Board of India(AWBI), in publishing an advertisement celebrating Animal Welfare Fortnight to uphold Gandhiji's message of Ahimsa; 'sponsored' by Animal Skin Traders. This was also in the name of Gandhiji and his land of Ahimsa

CCT's immediate refusal to accept 'blood money' as grants from AWBI, even returning the grant in 2008 is hailed by all right thinking people and our support base has grown ever since! As a mark of respect to his fond memory, a friend's family has facilitated in creating ASHIS BHATTACHARYA MEMORIAL FUND with the Compassionate Crusaders Trust, as a corpus fund to support our 'care-givers of the mutes' in their effort in initiating primary education/ further studies for their children. This helps in creating a new generation of compassionate citizens, a dream Ashis had nurtured! Arijit, who passed his secondary exams last year, has got fund-support for a new computer from ASHIS BHATTACHARYA MEMORIAL FUND.

In 2015, to express our appreciation to our sincere workers and to commemorate CCT's journey to 'adulthood', the Trustees had decided upon to support all the children of our nonexecutive staff members through a monthly direct deposit in the beneficiary's (child) bank account by way of recurring deposit for each child till he/she reaches the age of eighteen. This is to facilitate their career building as they become adults. It may be noted here, that most of the children are "first generation school goers. Abhisweta, as the first beneficiary, has got her fund on maturity year before last.

Five years on, Compassionate Crusaders' Centre for Animal Welfare, popular as Tollygunge Clinic has had a complete makeover with additional facilities for treatment of the 'mutes' in cool comfort; thanks to the generous support from the compassionate calcuttan couple, Mr. Subrato & Mrs. Subhra Ghosh. We continue to enhance the time and quality of treatment further, at our Clinic, a favorite of the caring animal lovers of our city. The year before last, a direct call facility to the clinic is introduced, for the benefit of the caring animal lovers. This is in addition to our 'round the clock' Animal Helpline. This year's regular maintenance included the repair of the public pavement around our clinic.

Karuna Kunj also has had a sparkling makeover," is one of the cleanest gardens ever", to quote from a media write up. Most significantly our staff there has been instrumental in implementation and maintenance of the upgraded facility. We have been adding to the facilities for fun-relief for the residents of Karuna Kunj. The Doggy-Kitty shower, unique in the country, continue to comfort them during oppressive summer heat. The "live streaming" of the activities of Karuna Kunj has become a real boon for the pet owners who are forced by circumstances to send their favourite pets to the shelter or even those who would love to have occasional glance through the 'final resting place' of the beloved pets.

Karuna Kunj cattery has become a Feline Disney Land, thanks To The Calcutta Construction Company, that has sponsored the extension of the Cattery. The Saturday Club's kind donation of the play-things like Jungle Gym, Slide, Swing for the enjoyment of the cats have acted like the icing on the cake!

Animals can only love and trust you or they can at the most fear you, hatred is alien to the animal world. Karuna Kunj is a rare place which has a "only love, no hatred" vive which is so much of a need of the hour in this strife stricken world full of hatred amongst humans. Karuna Kunj has a unique feature of planting of trees by families to commemorate their departed human members. Two families from Kolkata and one from Pune, apart from two of our work-associates have commemorative trees planted in fond remembrances as continuity of life by changing form into trees.

Karuna Kunj pet-burial continues to offer dignified farewell to the departed 'mute members the family'. The 'Memorial to Every Loving Pet' stands in all its gracious serenity, with the touching poem that brings a lump to all animal lovers' throat! Now a solar powered lamp post, courtesy Mr. Pradip Mitra, brightens the serene space.

Our recyclable pet-burial idea is spreading in human communities globally. New consumer movement has been

underway to promote natural burial grounds — where people are buried in biodegradable containers, without formaldehydebased embalming fluid or synthetic ingredients, and returned to the earth to compost into soil nutrients with a forest of trees marking the spot—are springing up. Hundreds of sites offering some form of natural burial have emerged in the UK, Australia, New Zealand, the US and Canada, with other countries coming on fast. Citizen-driven movements in support of natural burial can now be found in Europe, China, Japan, Germany, and Africa.

'Together in death as in life' is the slogan of the Green Pet-Burial Society, USA. They have opted for affiliation with us and put Karuna Kunj at Compassionate Crusaders Trust (CCT), Kolkata, India in their International Cemetery Directory.

Sputnik Sylvells Mickey's Mustard, my global-campaigner chihuahua, had been a pioneer in 'campaign through social media' which is now all pervading. He was known by all his friends across the globe including 5000 in Facebook (in 2009), as Sputnik, the Tiny crusader.

The commemorative Sputnik's Garden is an interesting addition to the rich greenery of Karuna Kunj, where about 80 varieties of trees and plants are recorded and documented. An area earmarked as a nursery of saplings and existing trees of about 50 varieties are nurtured in Sputnik's Garden. The saplings are multiplied regularly for free distribution to the children for greening the community. The garden along with the basic maintenance of the greenery include a Rose bush, a Lilly pool and the latest addition of a Lotus Pond at Karuna Kunj are sponsored fully by Sputnik's family.

Sheru Singh Memorial is a piece of green & flowers in memory of Sheru, the departed pet of Kohli family. They wrote "Thank you so very much in assisting us to realize the power of love. We were so blessed to learn and share Sheru's love and

compassion with many more souls than ever imagined. It is truly an honor to work with you and your staff in Kolkatta. We are all related through love, a bond that is eternal. Sincerely", Veena, Honey, and Ruchi Kohli., Maryland, USA. As a silver Jubilee do Sheru's space has been recreated as a rose bush. We also planted a Millingtonia sapling on the front lawn of Karuna Kunj. Millingtonia also called 'latak chandani' is exquisitely sweet scented flowering plant common in Maharashtra and Karnataka. Mr. Sukriti Chakraborty from Pune has been instrumental in the choice of Millingtonia, Mr. Chakrabarti continues to encourage our boys at Karuna Kunj. During high intensity cyclone Amphan thousands of community trees and plants were uprooted and destroyed. Sputnik Garden has offered about 1000 potted saplings to the local authority to join hand in compensatory greening of the community at large.

There are regular young visitors & volunteers to cheer the 'mutes' in our care.

Fellow Calcuttans, Mr. Mohi Ranjan Halder and Rao sisters Uma & Lalita continue to be genuine supporters for the mutes, year after year.

We mention with gratitude, the kind gesture of the Hastings Chapel authorities for allowing us to park our Water Tanker for the animals round the year. Last year we have shifted the tanker to our Howrah unit as Kolkata Municipal Corporation has constructed a large "water hole" for the maidan ponies.

We deeply miss our very dear and respected Saralaji Birla, Veena Kohli and Dady C Dady for their unstinted support and guidance. We will miss & remember them till the end of time.

Now to the brass tacks, the resource aspects. CCT sails through, making best use of available resource, coming mostly from caring calcuttans.

Since the last nine years, we have had no financial help from the Government, either central or state. By sheer improved financial management and optimum utilization of resources, yet again we have improved on our balance sheet without any financial liability.

This year we have been successful in enhancing our Project Expenditure to 72%; this in spite of 28% increased expenditure on administrative costs.

CCT staff members are also adequately 'compensated' with additional service charges to meet the living cost.

Continuing on the positive trend of last nine years, CCT has achieved a zero liability in this financial year 2017-18 also. Plainly speaking, no unpaid bills, whatsoever! All these are achieved by the dedicated and matured handling of the affairs by our wonderful young team. The year before last, another positive change in our management is the introduction of our youngest trustee Sumantra Roy (our ex-CEO) as the prime decision maker in CCT's regular/routine matters. Other senior board members continue with their active advisory role. Sumantra's management skill is prompted by Napoleon Hill's words, "If you are not learning while you're earning, you are cheating yourself out of the better portion of your compensation." This 'change of baton' has immensely encouraged our team of young workers.

In addition we had put our allowable corpus as fixed deposit which have helped us to sail through the rough weather of Covid-19 and Amphan Storm so that the mutes in our care and their care-givers never felt the pinch of the happenings at large. I personally very strongly believe that all our helpers, supporters and Patrons all over the society will make up for this dent by their generosity sooner than we expect Help has come, mostly, from the goodwill and support of the people of Kolkata, a city famous for its warmth and kindness. We salute Calcuttans for their attitude and awareness, and recognize the vital role they play in the success of our endeavors.

Most importantly, we have never compromised on the quality of our service to the poor suffering animals of our city and elsewhere, which is after all the very reason for our existence.

To maintain the standard of our services to the 'mutes', we have procured a new Mobile Clinic (Mahindra Bolero Ambulance, BS-IV), with the fund-support from The Executrix of the will of the late Dady C Dady. "It looks good but more important, it will help thousands of animals...", one important initiator of the Project in Memory of Dady C Dady wrote back on seeing it's photographs.

We have phased out (scraped) our 18 year old Mobile Clinic (Mahindra Voyager) to save on fuel & maintenance cost. During the year before last, one of our vehicles, Bajaj Trax have been given over to our fledgling Howrah unit.

Most humbly we dedicate this achievement to the compassionate souls across the globe, who have been our supporters since Compassionate Crusaders started out on its journey in November 1993 with a corpus of only One Thousand Rupees.

I take this opportunity to offer some necessary clarification regarding our Report on Activity & Financial status.

Donors & Supporters- As it would be next to impossible to mention our innumerable donors in cash & kind., we mention donors of Rs.5000 & above, or regular donors of smaller amounts. As also those who help in raising and maintenance of infrastructure and facilities for the animals in our care. Other supporters mentioned, include all well meaning individuals/groups/corporates who give us continuous logistic support and lend their expertise on the relevant issues in the course of our crusade for compassion. Statement of Accounts - Some more clarification regarding our Statement of Accounts which reflects our financial activity. Statement of Accounts is prepared and duly audited, more in the format of the statutory requirement of the law of the land. At the first glance some expenditure may stare back at the beholder. As the 'bills' raised by essential services like telephone, electricity, fuel, vehicle repairs (mostly) have to be paid directly from the trust fund.

That apart there are varied expenditure which are directly settled by the donors, including food, medicines, infrastructure, maintenance which are never reflected in the 'financial' report. Whereas the assets created as well as fund saved by the 'direct' fund givers can not be reflected in the financial report either.

Transparency is our keyword, like previous years we are posting the financial and activity report on our website.

The regular pandemic of different zoonotic disease, latest being the Covid-19(it is widely believed to have been originated in one of the wild-meat market in south china) is a grim warning of the consequences of neglecting the importance of animal welfare. Philanthropists and social workers (including the medical fraternity) seldom realize that to help the health and economy of a society, it is vital to focus on preventive (rather than curative) health care.

Diseases spread through earth, water, food and air. Even the milk of a diseased cow has ill-effects. A baby born to an emaciated mother who has worms can be born with brain damage. Instead of spending countless millions, can't we do some judicious planning to reduce the need for curing people; taking steps to keep them healthy instead?

The media has been extremely supportive even though we could never offer them any thing other than our sincerity for the cause of compassion. Going to where the silence is. That

is the responsibility of a journalist: giving a voice to those who have been forgotten, forsaken, and beaten down by the powerful."- The Exception to the Rulers (2004) by Amy Goodman. As Edward G. Bulwer-Lytton said, The pen is mightier than the sword. I would like to take this opportunity to thank all the media personnel whose innate sensitivity and skillful pens and cameras voiced needs of the mutes and the Compassionate Crusaders' endeavor in creating a kinder world.

We remember with gratitude, the erstwhile Kolkata edition The Hindustan Times' daily publication of Compassionate Crusaders' Animal Helpline.

As also The Telegraph's coverage of our emergency pet care in their Metro Guide. Many pets have benefited by this action of theirs.

The Animal lovers of Kolkata can boast of their city being the only METRO CITY in the country to have a 24 Hour "ANIMAL HELPLINE"!

Our regular activity update, including pictures will be available at the Facebook profile "Compassionate Crusaders Trust" which has enhanced its following by Ten times since it was launched five years back; along with related Blogs and Youtube channel, "ANIMALCRUSADER" created and maintained by our E-team.

From 2015, we have started using e-media like WhatsApp for sending live videos/photos to the owners/rescuers as also people who are unable to accompany their departed pets in our Hearse van.

Last year we have started to show our shelter & pet memorial activities through "live streaming" for the benefit of the pet owners concerned; over a period of time we aspire to make it available for all our animal loving friends.

We will continue to post our year long activity details and audited accounts on our Website and Facebook. Both the Facebook www.facebook.com/animalcrusaders & the Website www.animalcrusaders.org display the Videos of some of our activities apart from regularly updated photographs... we hope to keep on adding more!

Before I finish I acknowledge with deep personal gratitude, for the role playedby our our out- going PATRON, DR MANU CHANDARIA, A PHILANTHROPIST AND business leader of international repute who wished to step down as he has turned ninety, last year and also by Shri Sidheswar, our mobile-service in charge, Shri Arup, our animal welfare person, Shri Partha Sarathi, Our Chief Accountant, and our junior-most, yet the most active trustee, Shri Sumantra. Never in the last 25 years of CCT, was so much owed by so many to so few, in this critical situation
